# The Consumer Price Index of Aklan:

## June 2013

(2006=100)

### YEAR-ON-YEAR PRICE SITUATION

#### CPI increases by 5.4 percent

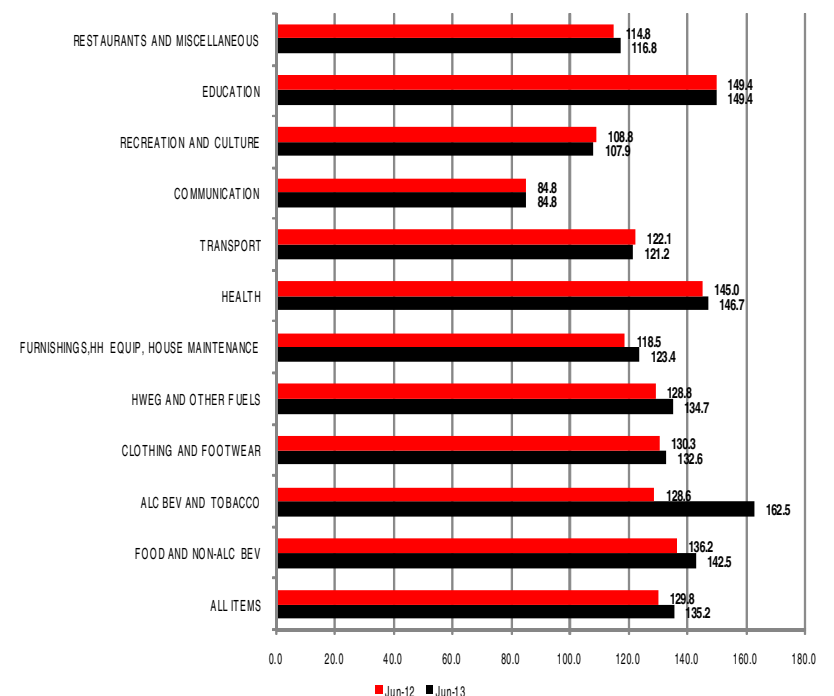
The price data in June 2013 showed an upward movement, particularly in consumer goods and services throughout the province. The consumer price index (CPI) in Aklan was placed at 135.2 in June 2013, from 129.8 of the same period a year ago, or an increase of 5.4 percent.

The highest increase in CPI was noted in Alcoholic Beverages and Tobacco with 33.9 percent (from 128.6 to 162.5), followed by Food and Non-Alcoholic Beverages with 6.3 percent mark (from 136.2 to 142.5), and Non-food items with 3.0 percent (from 124.4 to 127.4).

#### CPI by Commodity Group

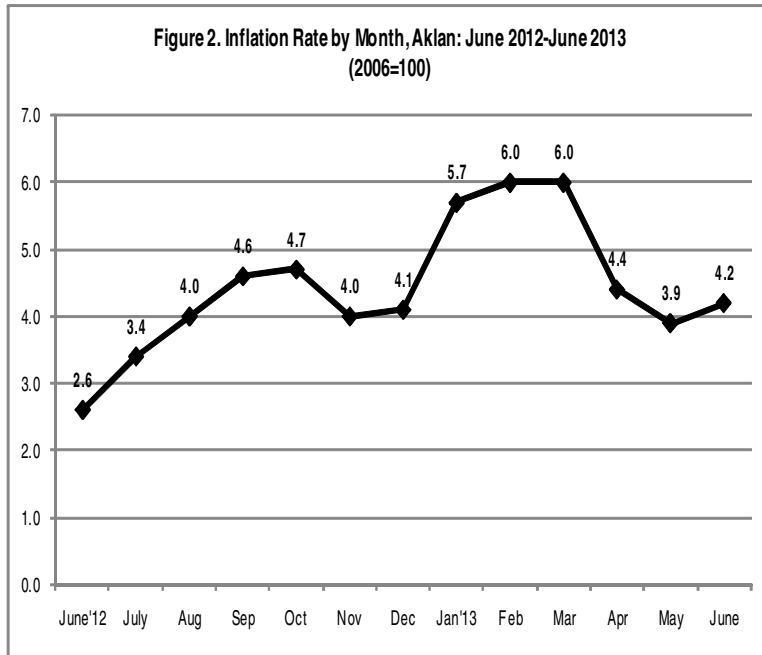
Among the commodity groups, Alcoholic Beverages and Tobacco has the highest index with 162.5 or an increase of 33.9 percent from last year's index of 128.6. This was followed by Education with 149.4 index points and Health with 146.7 percent mark. On the other hand, Communication remained to have the lowest index this month with 84.8 percent.

(2006=100)



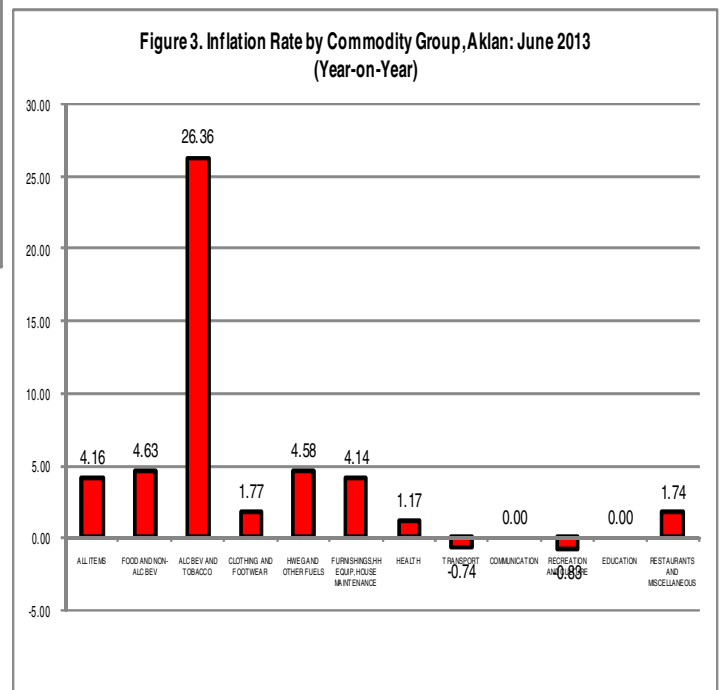
## Inflation rate increases by 1.6 percent

Figure 2 shows that the inflation rate of Aklan for the month of June escalated to 4.2 percent or an increase by 1.6 percent mark compared to the same period of last year's figure of 2.6. From June 2012 to June 2013, the average inflation rate registered at 4.4 percent. During the period specified, February and March 2013 were noted with highest inflation rate of 6.0 percent each, while the month of June 2012 registered the lowest IR in the province.



## Inflation rate by commodity group

Among the commodity group, Alcoholic Beverages and Tobacco posted a highest inflation rate of 26.4 percent. This is followed by Food and Non-Alcoholic Beverage, and HWEG and Other Fuels with 4.6 percent, respectively. Meanwhile, Furnishings, Household Equipment, and House Maintenance recorded a 4.1 percent mark. The rest of the commodities have an IR of 1.8 and below.



## MONTH-ON-MONTH PRICE SITUATION

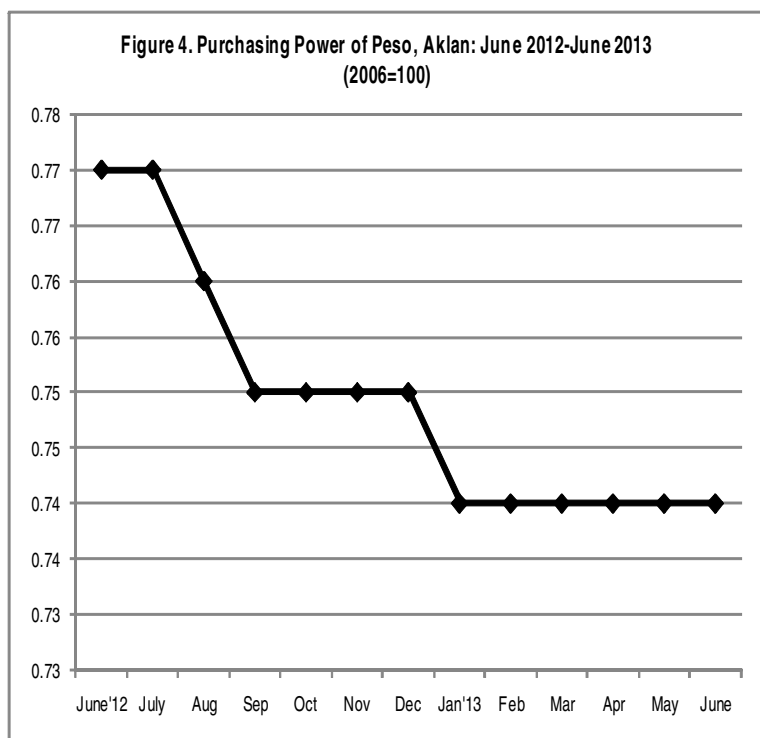
This month, the CPI for all income households in Aklan inched up by 0.07 percent after posting a 135.2 index point over last month's index of 135.1

The uptrend was the result of increase in prices of Recreation and Culture (1.60), Transport (0.41), HWEG and Other Fuels (0.37), Clothing and Footwear (0.30), and Furnishings, HH Equipment and Routine Maintenance of the House (0.08). Zero growth was observed to Food and Non-Alcoholic Beverages, Alcoholic Beverages and Tobacco, Health, Communication, Education, and Restaurants and Miscellaneous Goods and Services.

Under Food and Non-Alcoholic Beverages, commodities that showed a slower price movement composed of Sugar and related products (-4.16), Fruit (-1.25), Meat (-1.22), Vegetables (-0.41), Non-alcoholic Beverages (-0.34), and Milk, Cheese and Eggs (-0.07). However, an upward price trend was noted in Rice (1.36), Bread and Cereals (1.13), Corn (0.15), and Oils and Fats (0.13). Prices of Fish and Food Products NEC remained unchanged this month.

Non-food items increased by 0.31 percent as a result of price increase in most commodities especially Recreation and Culture.





## Peso value pegs at 0.74

The purchasing power of peso in Aklan in June 2013 was pegged at 0.74. This value remained constant over the last five successive months. The figure means that one peso (P1.00) in 2006 is worth seventy four (P0.74) centavos in June 2013. Interpreted in another way, this means that the same basket of goods and services worth P74.00 in 2006 can be bought at P100.00 in June 2013.

## Explanatory Notes

**Consumer Price Index (CPI)** - is an indicator of the change in the average retail prices of a fixed basket of goods and services commonly purchased by the households relative to a base year. It shows how much on the average, prices of goods and services have increased or decreased from a particular reference period.

The June 2013 CPI Report was derived from the results of the 2006-based CPI survey comprised of eleven (11) major commodity groups. These are the following: Food and Non-alcoholic Beverages; Alcoholic Beverages and Tobacco; Clothing and Footwear; Housing, Water, Electricity, Gas and Other Fuels; Furnishings, Household Equipment and Routine Maintenance of the House; Health; Transport; Communication; Recreation and Culture; Education; Restaurants and Miscellaneous Goods and Services.

**Inflation rate** is defined as the annual rate of change or the year-on-year change in the CPI.

**Purchasing power of peso** is a measure of the real value of the peso in a given period relative to a chosen reference period.

**Market basket** is a term used to refer to a sample of goods and services that are commonly purchased and bought by an average Filipino household.

**Base period or Base Year** is the period, usually a year, at which the index number is set to 100. It is the reference point of the index number series. In this report, 2006 is used as the base period.
